Airbnb Discussion. Letters have been sent to all Nebraska properties on their platform. They will begin lodging tax collection in September of 2019.

## c. Discussion of Budget Reserve

Proposed Budget 19-20 with existing \$500,000 reserve and another one with \$250,000 reserve. Finance Committee recommends to move \$500,000 reserve down to \$250,000. To get to 2.2 million dollar level.

Motion to accept and tie together Overall Fiscal 19-20 Budget and Discussion of Budget Reserve by Lehl. Loseke seconded the motion.

Roll call vote – Commissioners in favor: Barner, Kuhn, Lehl, Loseke, McFarland, Olson, Sabin, Sortum, Stavas. Opposed: none. Abstain: none. Chapo and Jasnoch not present. Motion passed to adjust budget reserve to \$250,000 and to re-evaluate every year.
